**AMR Cost Recovery Charge** - This monthly charge recovers incremental costs associated with the installation of automated meter reading equipment.

**PIPP Rider** - This rider recovers costs of the Percentage Income Payment Plan for certain low-income customers.

**Uncollectible Expense Rider** - The PUCO approved a rider for the Ohio gas distribution companies that allows them to recover the actual cost incurred for uncollectible expense through an annually adjustable rider rather than through base rates, which is how such costs were recovered in the past. This rider applies to all SSO, SCO, MVR and Energy Choice customers.

**Surcredit Rider** - The surcredit rider is applied to the volumes (mcfs) delivered to Energy Choice customers to reduce the transportation rates for an amount factored into Dominion East Ohio's transportation rate related to assessments it receives from the PUCO and the Ohio Consumers Council based on commodity sales. In order to improve the comparability of rates, this rider shall also be applied to the transportation rate of SSO volumes, but shall be offset by a charge in the same amount added to the standard service offer gas cost rate resulting in no net impact on the SSO customers.

**Migration Rider** - This rider, which applies to all SSO and Energy Choice customers, recovers the costs to DEO of balancing deliveries of gas to Dominion East Ohio's system and the customers' actual consumption.

**Demand Side Management Rider** - This charge recovers costs to promote energy efficiency and conservation.

**Standard Service Offer (SSO) Rate** - This is the cost of acquiring natural gas for sale to customers who purchase gas from Dominion East Ohio.

**Standard Choice Offer (SCO) Rate** - This gas cost rate is a service provided by competitive retail natural gas (CRNG) suppliers participating in DEO's Energy Choice program.

**Monthly Variable Rate Commodity Service (MVR)** - This gas cost rate is a service provided by competitive retail natural gas (CRNG) suppliers participating in DEO's Energy Choice program.
